WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Ralph N. Armstrong II	General Services	\$ 915	Mr. Armstrong is an Assistant Civil Engineer in the Solid Waste Division. He suggested that the mechanical planimeter be replaced with an electronic volumetric planimeter with processor. This is expected to save \$3,047 in the first year in the costs of contract planimetry and in-house planimetry.
Maureen Whelan	General Services	\$ 835	Ms. Whelan is a Senior Clerk in the Buildings Division. She suggested that a postage metering machine be purchased during a special sale by the manufacturer. By purchasing a discontinued model of the machine during the sale period, the Division saved \$2,789 of the amount budgeted for the purchase.
Charlie C. Jones	Water Utilities	\$ 720	Mr. Jones is a Plant Mechanic in the Water Quality Division. He suggested that bronze cylinders used at the Alvarado Filtration Plant be fabricated in-house rather than purchased from a vendor. This is expected to save \$4,804 in the first year in equipment costs. This is a partial award pending a final 12-month review.
