Raymond M. Dobbs	Police	\$ 490	Mr. Dobbs is a Police Sergeant. He suggested that store security personnel complete shoplift reports prior to contacting the Police Department. His suggestion has been in use since July, 1978, and it generated a savings of \$4,878 in the first year in labor costs.
Caroline C. McCullagh	Building Inspection	\$ 345	Ms. McCullagh is a Building Inspection Technician II in the Building Inspection Department. One year ago she earned a partial award of \$350 for her suggestion to relocate the waiting areas for the Zoning and Building Inspection counters. One year's experience has shown a savings of \$2,324 in costs for leasing office space.
Rae Ann Harper	Police	\$ 225	Ms. Harper is an Intermediate Typist in the Traffic Division. One year ago she earned a partial award of \$210 for her suggestion to revise the filing system for moving citations and traffic warnings. One year's experience has shown a savings of \$1,455 in labor costs. This is the remainder of her award.
