John R. Crowell	Police	\$ 205	Mr. Crowell is an Evidence Technician in the Crime Laboratory. He suggested that a check-off, pretyped examination report be used in the processing of latent fingerprint examinations. This is expected to save \$682 in the first year in labor costs.
Phil T. Stone	Park & Recreation	\$ 200	Mr. Stone is a Life Guard III in the Coastal Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion that automatic garage door openers be installed at the Mission Beach Lifeguard Station. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Anne N. Dodson	Water Utilities	\$ 170	Ms. Dodson is an Assistant Chemist at the Point Loma Wastewater Treatment Plant. She suggested that the Hach Micro Method be adopted for doing Chemical Oxygen Demand analyses. This is expected to save \$241 in labor and material costs. In addition, it is considered to be a significant safety improvement.
