John C. Kersell Richard A. Creighton	General Services	\$ 160	Mr. Kersell and Mr. Creighton are Equipment Mechanics in the Equipment Division. They suggested that the method of attaching the belting on the beach screens be modified. This is expected to save \$541 in the first year in labor and material costs.
Denise M. Knobloch	Park & Recreation	\$ 150	Ms. Knobloch is a Grounds Maintenance Worker II in the Eastern Division. She suggested that the method of securing water valve boxes be modified to reduce vandalism. Over a ten month period Standley Park experienced vandalism which cost the City approximately \$500. The suggester's valve box locking devices played the major role in stopping the vandalism.
John T. Mulvey	City Clerk	\$ 120	Mr. Mulvey is an Intermediate Clerk. He suggested that a positioning guide which he designed and fabricated be used on the ABR-100 camera. This is expected to save \$405 in the first year in labor costs.
