Maria A. Cabrera	Water Utilities	\$ 25	Ms. Cabrera is an Intermediate Typist in the Systems Division. She suggested that a decal be affixed to the glass middle section of the entrance to the Systems Division office. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Maureen Whelan	General Services	\$ 20	Ms. Whelan is a Senior Clerk in the Buildings Division. She suggested that different window envelopes be purchased to reduce metering problems in the mailroom. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Iris E. Price	Personnel	\$ 20	Ms. Price is an Intermediate Typist in the Testing Section. She suggested that the Handicapped Applicant Information Form be revised to more clearly indicate who is to complete the form. This is expected to save \$59 in the first year in paper and printing costs.
