BLACKMAN appealed the decision of the Planning Commission in failing to approve Parcel Map 02-227-0 which proposes a 4-lot parcel map of Parcel 2, Parcel Map 839, located at the south termini of Nogales Drive and Mar Scenic Drive in the R-1-15 Zone and within the boundaries of the Torrey Pines Community Plan area; and

WHEREAS, on February 18, 1982, the Planning Commission of The City of San Diego voted 4 to 2 to deny the parcel map; and

WHEREAS, on February 24, 1982, pursuant to the provisions of Section 102.0308 of the San Diego Municipal Code, VERNON H. BLACKMAN appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on June 22, 1982, and testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; and

WHEREAS, the City Council in considering said appeal is empowered by the provisions of Municipal Code, Section 102.0308, to affirm, reverse or modify, in whole or in part, any determination of the Planning Commission subject to the limitations as are placed upon the Planning Commission by the Municipal Code; and

WHEREAS, on June 21, 1982, VERNON H. BLACKMAN withdrew his appeal of the Planning Commission decision; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of VERNON H. BLACKMAN is denied on the basis of his withdrawing his appeal.
