
WHEREAS, AB 1152, introduced in the State Legislature by Assemblyman Kapiloff, would amend the San Diego Unified Port District Act to require the Port District to establish a \$2 million revolving fund out of which the County and each of the eight coastal cities in the county with tidelands could be reimbursed pro rata for expenses of tidelands maintenance, erosion and restoration; and

WHEREAS, such an amendment would cause Port District generated funds to be expended in areas and in cities outside of those that make up the Port District and is not in the best interest of The City of San Diego and its people and should be opposed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego declares itself to be in opposition to AB 1152 and that the Intergovernmental Relations Department, through the City's representative in Sacramento, take whatever action is necessary to make such opposition known to the Legislature in its deliberation on the bill.
