APPROVING MAP OF GENESEE VILLAS

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by RONALD C. PARKER, a Licensed Land Surveyor, entitled "GENESEE VILLAS Being a subdivision of that portion of Lot 12 of Lemona, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 684, filed in the office of the County Recorder of said San Diego County, September 15, 1891, and of that portion of Plumar Street now vacated and closed to public use which lies between the easterly line of said Lot 12 and the easterly line of said Map No. 684.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Genesee Avenue, adjacent and contiguous to portions of Lot 1, as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, an easement with the right of ingress and egress for the

construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, an easement for open space over, under, upon and across a portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that those abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as well as the easement for open space, all as granted and shown on the map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
