BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street, drainage and sewer easement deeds of GENSTAR DEVELOPMENT INC., a New York corporation, and J. L. ELDER CORPORATION, DBA LESLEY MCBRIDE CORPORATION, executed in favor of The City of San Diego, bearing dates of August 26, 1981, and September 14, 1981, respectively, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256659 -1 and RR- 256659 2, granting to said City easements for street, drainage and sewer purposes in a portion of Rancho De Los Penasquitos, according to Map recorded in Patent Book 2, Page 385, and in a portion of Lot 4, Section 20, T14S, R2W, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named MERCY ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
