

BE IT FURTHER RESOLVED, that the City Manager hereby authorizes to amend the consultant agreement with Marc Tarasuck, AIA & Associates from \$8,250 to \$25,200.

BE IT FURTHER RESOLVED, that the transfer of \$115,470 from Fund 30248, CIP 39-032.0, Phases I and II Gaslamp Public Improvements, to Fund 30248, CIP 20-107.5, Gaslamp Quarter Vest Pocket Park is hereby approved.




