
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street easement deeds of TITLE INSURANCE AND TRUST COMPANY, a corporation, as Trustee of its Trust No. 4R-8358-00-1; ROBERT DANIEL BARCZEWSKI, as Trustee under Declaration of Trust dated August 10, 1977; LEON BRUKMAN, a married man as his sole and separate property; and PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing dates of January 21, 1982, August 3, 1981, February 2, 1982, and January 18, 1982, respectively, copies of which deeds are on file in the Office of the City Clerk as Document Nos.

RR- 256695-1, RR- 256695-2, RR- 256695-3 and RR- 256695-4, granting to said City easements for public street purposes over, along and across portions of Sections 9, 10 and 16, in Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named BLACK MOUNTAIN ROAD AND VIA DE PICO ALTO.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
