RESOLUTION INITIATING PROCEEDINGS FOR THE
ESTABLISHMENT OF THE SHELTER ISLAND, AIRPORT, AND
EMBARCADERO STREET LIGHTING AREAS.

WHEREAS, pursuant to Sections 65.0201, et seq. of the San Diego Municipal Code and Sections 22500, et seq. of the California Streets and Highways Code, The City of San Diego proposes the formation of the SHELTER ISLAND, AIRPORT, AND EMBARCADERO STREET LIGHTING AREAS; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest, convenience and necessity require and it is the intention of this Council to order the formation and establishment of a maintenance district pursuant to the San Diego Maintenance District Procedural Ordinance of 1975 (commencing with Sections 65.0201, et seq., San Diego Municipal Code) for the maintenance of public facilities within the boundaries of the district to be known as SHELTER ISLAND, AIRPORT AND EMBARCADERO STREET LIGHTING AREAS. The maintenance shall include but is not limited to the supplying of energy to street lights, replacement of lamps and glassware, and periodic cleaning and painting of standards.

2. The proposed areas are generally described as follows:

The abutting property and rights-of-way of
Shelter Island Drive southeasterly of Shafter Street;
Harbor Drive from Scott Street to Hawthorn Street

including Laurel Street westerly of Pacific Highway;
Harbor Drive from Hawthorn Street to 32nd Street
including Broadway westerly of Pacific Highway, and
Pacific Highway from Broadway southerly to Harbor
Drive, as shown on the maps on file in the office of
the City Clerk as Document No. 768517.

3. It is proposed that the assessments shall commence July
1, 1982.

4. That the City Engineer is hereby directed to prepare
and file a Report in accordance with Sections 22565, et seq. of
the Streets and Highways Code of the State of California.
