

that it hereby approves and adopts the LA JOLLA and LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM and directs submittal of the La Jolla Community Plan, the La Jolla Shores Precise Plan and the LA JOLLA and LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM to the Coastal Commission for certification as the land use portion of the Local Coastal Program, pursuant to the California Coastal Act of 1976.
