AND WHEREAS, the bid of \$2,533,092.66 of Bank of America is the highest bid for the notes, considering the interest rate specified and the premium, if any, offered;

NOW, THEREFORE, the Council of The City of San Diego hereby finds, determines, declares and resolves as follows:

Section 1. Said bid of Bank of America for the notes is hereby accepted and the City Treasurer is hereby authorized and directed to deliver the notes to said purchaser thereof upon payment to the City Treasurer of the purchase price, to

wit: The par value thereof and a premium of \$1,237.00, together with accrued interest thereon to date of delivery, the notes to bear interest at the rate of nine and fifteen one hundredths percent (9.15%), payable at the maturity of the notes, and to be of the denominations as specified by said purchaser thereof.

Section 2. All bids except said accepted bid are hereby rejected and the City Clerk is hereby directed to return to the unsuccessful bidders their several checks accompanying their respective bids.

Section 3. The City Clerk is hereby directed to cause to be prepared a sufficient number of notes, said notes to show on their face that the same bear interest at the rate aforesaid.
