WHEREAS, David Holmes Morris was born in Cincinnati, Ohio, on June 23, 1943; and

WHEREAS, his family moved to San Diego not long thereafter and David spent most of his life in San Diego; and

WHEREAS, he graduated from Hoover High School in 1961 and attended San Diego State University, where he played varsity football under Don Coryell, graduating therefrom in 1965; and

WHEREAS, he started working for The City of San Diego in the Personnel Department in June 1966 and rose rapidly to gain the appointment as Assistant Personnel Director in 1972; and

WHEREAS, during this time, he attended the University of San Diego School of Law at night, graduating in June 1974 and gaining admission to the California State Bar in December of that year; and

WHEREAS, David joined the City Attorney's office in July 1977 and advanced through the Criminal Division to the Civil Division, where, because of his expertise in personnel affairs, he was assigned responsibility for all personnel, retirement, and labor relations matters; and

WHEREAS, as a result of his drive and dedication, he gained a widespread reputation as an expert in those areas of the law, frequently being called upon by other organizations for advice; and

WHEREAS, he was admired and respected by his adversaries, who also sought his advice, and loved by friends and co-workers who frequently sought his counsel; and

WHEREAS, David died suddenly on July 1, 1982 at the age of 39, leaving behind a loving wife and family and many friends and colleagues; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of itself and The City of San Diego, does hereby express its deep sorrow upon the passing of David Morris, our friend and colleague, whom we will miss for a very long time but will never forget.
