WHEREAS, on March 9, 1981, the Council of The City of San Diego adopted Resolution No. 253768, including an Exhibit A thereto, designating eight projects for funding from the California Parklands Act of 1980; and

WHEREAS, due to a favorable bid to complete Phase II of the Spreckels Organ Pavilion renovation, it is now desirable to revise Priority 1 of Exhibit A; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Exhibit A of Resolution No. 253768 of the Council of The City of Diego be and is hereby amended to add Phase III to Priority 1 (Spreckels Organ Pavilion - Renovation) for the purpose of completing landscaping, paving, walkways, and seating improvements associated with the project.

BE IT FURTHER RESOLVED, that the City Manager or his representative is hereby authorized to perform all necessary acts to secure the funds from the 1980 State Bond Act.
