BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by JOHN M. LEACH, a Registered Civil Engineer, entitled "BERNARDO HEIGHTS - UNIT NO. 9 RESUBDIVISION Being a subdivision of Bernardo Heights - Unit No. 9, Map No. 9719 in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County July 15, 1980 as File No. 80-222514 including Via Sabroso, Via Undoso, Calle Vidiera and Calle Ambiente as closed and vacated to public use, together with a portion of Bernardo Heights Unit No. 8, Map No. 9716, being Via Sabroso and Via Undoso as closed and vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


