APPROVING MAP OF OCEAN BREEZE 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by MICHAEL L. STEVENS, a Registered Civil Engineer, entitled "OCEAN BREEZE 1 Being a subdivision of a portion of Lot G in Block 7 of Central Homestead, according to Map thereof No. 358, filed in the office of the County Recorder of San Diego County, January 25, 1879; and a portion of Lot 18 in Block 2 of Orcutt's subdivision, according to Map thereof No. 426, filed in the office of the County Recorder of San Diego County, November 16, 1887, together with that portion of 33rd Street, adjacent thereto, vacated and closed to public use; all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on


behalf of The City of San Diego an easement for open space over, under, upon and across Lot 13, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, together with the open space easement, all as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
