RESOLUTION NUMBER R- 256780

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego hereby approves placing the issue of a two-cent local option fuel tax on the November 1982 Countywide Ballot and approves ballot language contained in Exhibit "A."

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized, for and on behalf of said City, to execute an agreement with the County of San Diego and the other 15 cities in the county specifying the method of distribution of any funds generated by a voter-approved local option fuel tax, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 256780 .

BE IT FURTHER RESOLVED, that it is the intent of this City Council that new revenues generated from this local option fuel tax be used to supplement local revenues used for transportation purposes.
