RESOLUTION NUMBER R- 256785

Adopted on JUL 12 1982

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where for a period of five consecutive years the street to be vacated has been impassable for vehicular travel and during such period no public money has been expended for maintenance; and

WHEREAS, the abutting property owner has requested the vacation of a portion of Bancroft Street adjacent to Lot 9, Block 9 of Eastern Addition, Map 295, to facilitate development of her property; and

WHEREAS, a portion of Bancroft Street has been impassable for five consecutive years and no public money has been expended for maintenance; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That a portion of Bancroft Street adjacent to Lot 9, Block 9 of Eastern Addition, Map 295, as more particularly shown on Drawing No. 15633-B on file in the office of the City Clerk as Document No. RR- 256785-1 which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

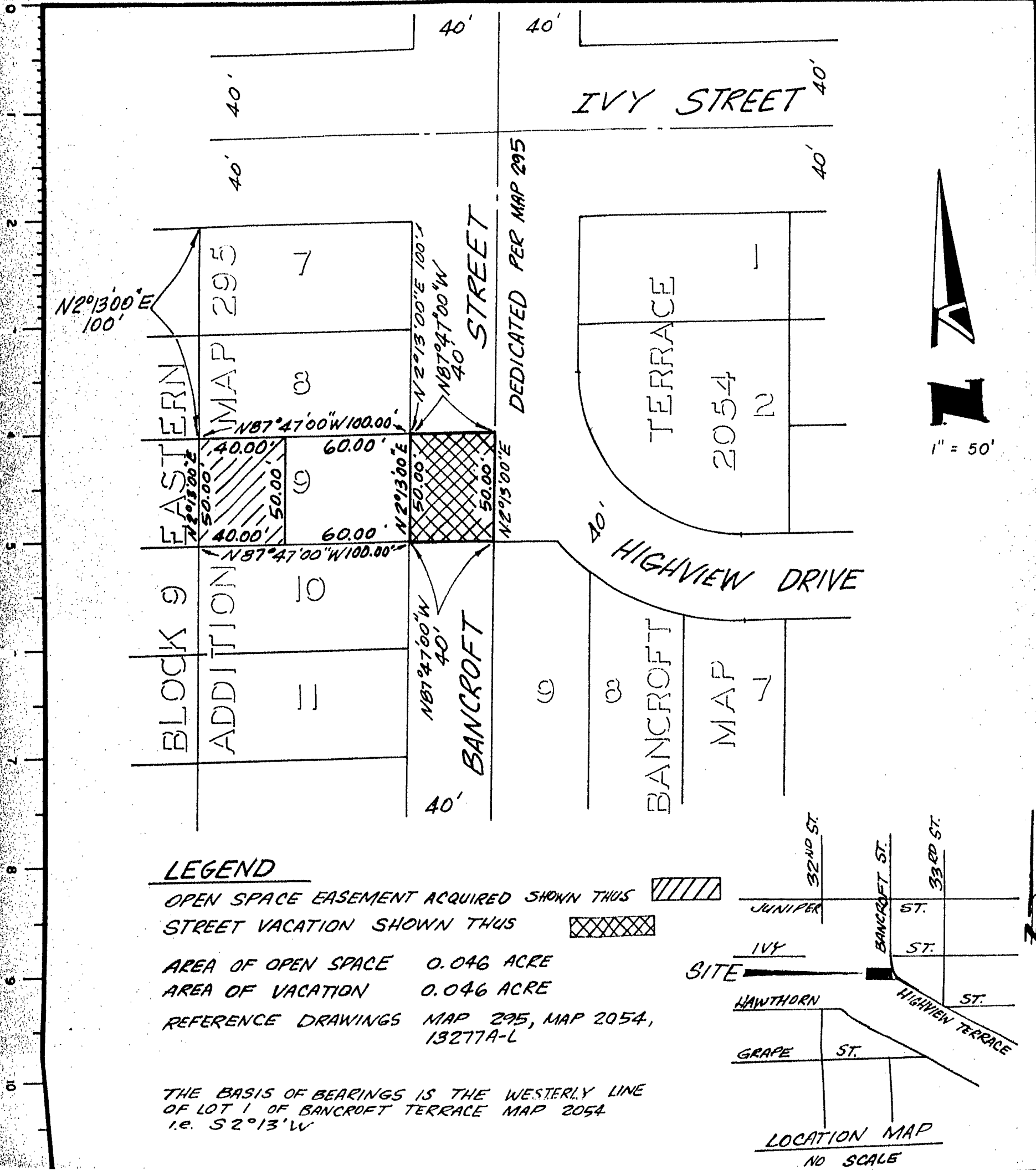
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

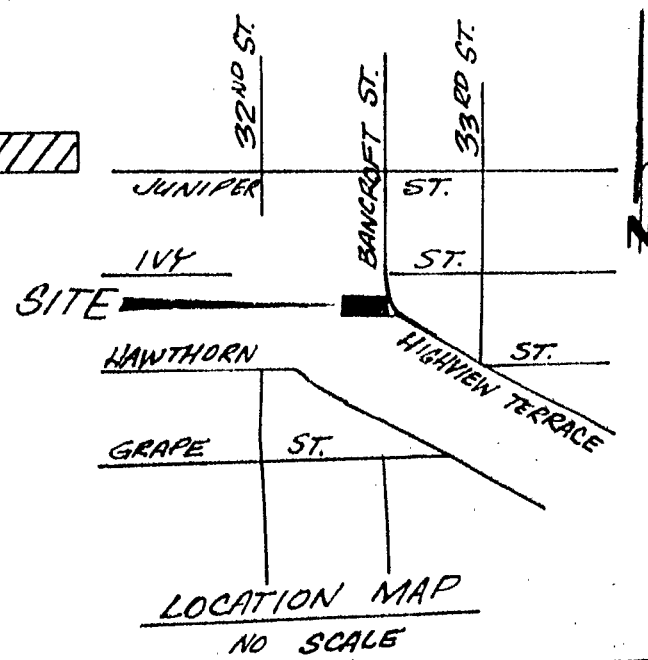

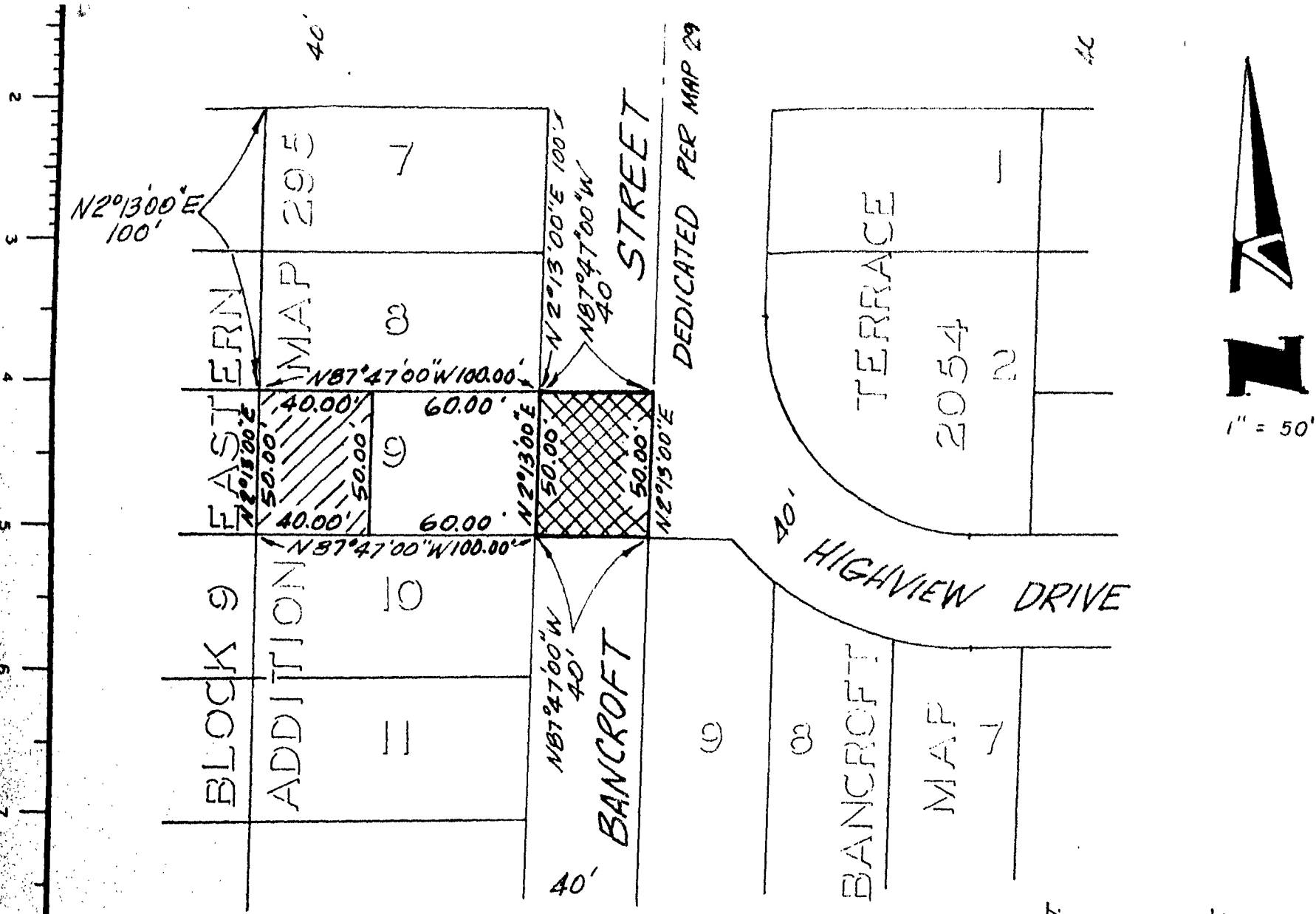
OPEN SPACE EASEMENT ACQUIRED SHOWN THUS

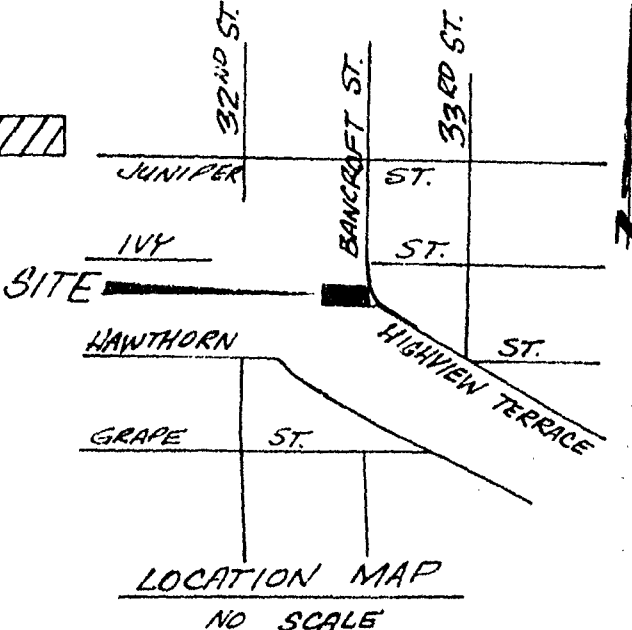
