RESOLUTION NUMBER R- 25679A

Adopted on JUL 13 1982

WHEREAS, the University of San Diego Medical Complex is a major medical complex serving the uptown area of the city; and

WHEREAS, the number of employees the Center employs make a positive contribution to the city's economic base; and

WHEREAS, the number of visitors, employees, and patients driving vehicles to and from the Medical Center is projected to be 14,650 ADT's in 1982; and

WHEREAS, the City Council has asked the University Medical Center to act in good faith by providing parking for its visitors, employees, and patients to relieve the parking congestion on the residential streets surrounding the Center;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego will endorse the University Medical Center to construct a major parking garage to meet its parking needs.

BE IT FURTHER RESOLVED, that The City of San Diego will endorse the provision of access to the UCMC parking garage via Hotel Circle and Mission Valley, as well as the existing access via Dickinson and Washington Streets; with the following conditions:

1. As part of the EIR process, The City of San Diego shall identify potential traffic problems in both communities and develop with the University of California a plan which will solve access and circulation problems and include a funding plan to mitigate these problems.

2. City of San Diego approval of the parking structure will be contingent upon City of San Diego approval of the plan proposed to solve access and traffic problems generated by the parking structure.

3. Incorporate in the plans, alternate modes of transportation such as bike paths and mass transit connections.

4. The design of the parking structure be visually sensitive to the surrounding area.

5. A representative from the Uptown Community Planners and the Mission Valley Unified Planning Committee be included as members of the design committee for the University of California Parking Structure.

6. Physical barriers or some other control be included to eliminate through traffic between the Uptown Community Planning area and the Mission Valley Planning area, with the exception of emergency vehicles.


7. Oppose any future expansion that would require additional parking structures, unless effective mitigations measures are identified and a fair share of funding for these measures is provided by UCMC.

BE IT FURTHER RESOLVED, that The City of San Diego

understands that the University Medical Center will comply with all local, state, and federal laws regarding the construction of this garage and new access road.
