APPROVING MAP OF HIGH COUNTRY WEST UNIT NO. 10

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled "HIGH COUNTRY WEST UNIT NO. 10 Being a subdivision of a portion of Parcel 1 of Parcel Map 11645, filed in the office of the County Recorder of San Diego County on September 9, 1981, in the City of San Diego, County of San Diego, State of California, together with portions of Bernardo Center Drive and Camino Del Norte, all as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Bernardo Center Drive for public purposes, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, an easement for general utility purposes over, under, upon and across a portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to

endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; that said portion of a street is accepted on behalf of the public as heretofore stated; and that the easement for general utility purposes, as granted and shown on this map, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
