APPROVING MAP OF MIRAMAR RIDGE

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by DONALD R. ROGERS, a Licensed Land Surveyor, entitled "MIRAMAR RIDGE Being a subdivision of a portion of the Northeast Quarter of the Southwest Quarter, all in Section 10, Township 15 South, Range 3 West, San Bernardino Meridian in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Miramar Place and a portion of Marindustry Drive for public purposes, and said street and portion of a street are hereby declared to be a public street and a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication a portion of Lot 5, marked "Reserved for Future Street," as shown on this map, under the provisions of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the

construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the open space easement over, under, upon and across a portion of Lot 13, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that said public street and portion of a public street are accepted on behalf of the public as heretofore stated; that said Council has rejected a portion of Lot 13 marked "Reserved for Future Street,"; and that the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, together with the open space easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
