WHEREAS, The City of San Diego has one 1965 International Van Pelt fire apparatus (City No. F.O. 1242) which is no longer needed by the Fire Department; and

WHEREAS, the Fire Department of the City of Tijuana, Mexico, has a need for said fire apparatus; and

WHEREAS, acquisition of this fire apparatus by the City of Tijuana, Mexico, will enhance that city's fire fighting ability and lessen the dependency of the Tijuana Fire Department on The City of San Diego's Fire Department and will increase the Tijuana Fire Department's ability to work in conjunction with The City of San Diego's Fire Department on fires that occur along the border; and

WHEREAS, Fire Chief Eduardo Martinez Barajas of the City of Tijuana, Mexico, in a letter to City of San Diego Fire Chief Earle G. Roberts, attached hereto as Attachment A, has agreed to respond with at least one fire engine and crew to fires that occur on or near the boundary line that exists between the City of Tijuana and the City of San Diego when requested to do so by the Fire Chief of The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to give to the City of Tijuana's Fire Department said 1965 International Van Belt fire apparatus (City No. F.O. 1242) in exchange for the

cooperation of the Fire Department of the City of Tijuana in assisting with the fighting of fires that occur on or near the boundary line that exists between the City of Tijuana and the City of San Diego.
