WHEREAS, that portion of Harbor Drive from Kettner
Boulevard to Fifth Avenue is no longer needed for present or
prospective public use; and

WHEREAS, the construction of the realignment of Harbor Drive has been completed and opened to traffic; and

WHEREAS, those properties adjoining the street to be vacated are under the jurisdiction of the San Diego Unified Port District; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That that portion of Harbor Drive from Kettner Boulevard to Fifth Avenue, as more particularly shown on Drawing Nos. 20372-1-D and 20372-2-D, on file in the office of the City Clerk as Document Nos. RR-256818-/ and RR-256818-2 which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves and excepts from the foregoing vacation the permanent easements as more particularly described hereinafter:

Reserving and excepting to The City of San Diego, the right, easement and privilege of placing, constructing,

repairing, replacing, maintaining, using and operating public utilities of any kind or nature, including, but not limited to general utilities, water and drain facilities, and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon acquisition of an encroachment permit from the City Engineer pursuant to the Municipal Code of the City, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately The City of San Diego shall have the right to owned pipelines. reserve and except from vacation and abandonment, easements and rights pursuant to any existing franchise or renewals thereof, at any time, or from time to time, to construct, maintain, operate, replace, remove, renew and enlarge overhead or underground lines of pipe, conduits, cables, wires, poles and other structures, equipment and fixtures for the transportation or distribution of electrical or electronic energy and natural gas and for incidental purposes including access to protect the property from all hazards in, upon, over and across the above described portions of streets to be vacated and abandoned.

The easements reserved herein are in, under, over, upon, along and across that portion of Harbor Drive between Kettner Boulevard and Fifth Avenue, as vacated by this document and as more particularly shown on Drawing Nos. 20372-1-D and 20372-2-D, on file in the office of the City Clerk as Document Nos. RR- 256818 -/ and RR- 256818 -2.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
