RESOLUTION NUMBER R- 256822

Adopted on JUL 19 1982

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to NOBEL DRIVE from Lot 2 of La Jolla International Gardens, Map 10247, and

WHEREAS, LA JOLLA INTERNATIONAL, LTD., a limited partnership, has requested that the City revest these abutter's rights of access in the property for the relocation of a driveway into NOBEL DRIVE; and

WHEREAS, said abutter's rights of access were acquired at no cost and only have a nominal value under the circumstances; and

WHEREAS, LA JOLLA INTERNATIONAL, LTD. has paid all City costs in connection with processing the matter of quitclaiming the access rights, and

WHEREAS, the processing cost of the revestment of access rights will be the consideration for the sale of the City's rights, and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 256822 , quitclaiming to LA JOLLA INTERNATIONAL, LTD.,
the revestment of those abutter's rights of access in and to NOBEL
DRIVE from Lot 2 of La Jolla International Gardens, Map 10247, as
more particularly described in said quitclaim deed.

2. That the City Clerk shall cause the quitclaim deed and a
certified copy of this resolution to be recorded in the office of
the County Recorder.
