BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with SPARLING, Division of Envirotech Corporation, for services of electronic technicians to install, calibrate test diagnose and repair various instruments and installations at the Point Loma Treatment Plant and Pump Stations I and II, under the terms and conditions set forth in the Second Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 256853 .

BE IT FURTHER RESOLVED, that the expenditure of \$186,300 is hereby authorized from Utilities Sewer Fund 41506, solely and exclusively for this project.

BE IT FURTHER RESOLVED, that the City Auditor & Comptroller is hereby authorized to transfer within the Utilities Sewer Fund 41506 the sum of \$35,300 from the Unallocated Reserve (70679) to Maintenance, Point Loma Treatment Plant (70235).
