Jonathan T. Harker Joe A. Rametta	Engineering & Development	\$4,500	Mr. Harker and Mr. Rametta are Junior Engineering Aides. One year ago they earned a partial award of \$500 for their suggestion to install self-compensating air switches in traffic counters. One year's experience has shown a savings of \$4,101 and increased production of traffic counters worth \$23,040. This is the remainder of their award.
Maureen Whelan Paul Michalek	General Services	\$1,645	Ms. Whelan is a Senior Clerk and Mr. Michalek was a Building Services Supervisor in the Buildings Division. One year ago they earned a partial award of \$1,900 for their suggestion to presort outgoing U.S. mail by zip code. One year's experience has shown a savings of \$11,825. This is the remainder of their award.
Richard E. Smith	Water Utilities	\$1,375	Mr. Smith is a Waste Water Plant Operator in the Metro Waste-water Division. He suggested that the station rig an air line to use to unload ferric chloride. This is expected to save \$9,158 in the first year in costs for delivery fees charged by the supplier. This is a partial award pending a final 12 month review.
