One year ago he earned a partial award of \$20 for his suggestion to use hollow break-off bolts for fire hydrant installation. One year's experience has shown a savings of \$6,627. This is the remainder of his award.
Daniel Karsh Larry L. Griffin	Police	\$ 635	Mr. Karsh is a Police Sergeant and Mr. Griffin is a Police Officer II. One year ago they earned a partial award of \$695 for their suggestion to include a provision for a 10% discount to the City in tow company contracts. One year's experience has shown a savings of \$4,435. This is the remainder of their award.
Henry C. Stoker	Police	\$ 565	Mr. Stoker is an Equipment Service Supervisor. One year ago he earned a partial award of \$820 for his suggestion to sell used tires to a recapper rather than discarding them. One year's experience has shown a savings of \$4,622. This is the remainder of his award.
