<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert L. Davis	General Services	\$ 435	Mr. Davis is a Plumber Supervisor in the Buildings Division. He suggested that a gas fired heater be installed in the tire shop at 20th and B so that the main boiler could be turned off at night. This is expected to save \$1,454 in the first year in gas and electric costs.
John H. Vaughn	Fire	\$ 410	Mr. Vaughn is a Fire Captain. One year ago he earned a partial award of \$200 for his suggestion to cover wall maps in Fire Stations with a protective material. One year's experience has shown a savings of \$6,089. This is the remainder of his award.
Desmond P. Marmion Hollis Pleasant	General Services	\$ 320	Mr. Marmion is a Motor Sweeper Supervisor and Mr. Pleasant is an Equipment Operator I in the Streets Division. One year ago they earned a partial award of \$265 for their suggestion to use a gradall to remove trash from inoperative refuse vehicles. One year's experience has shown a savings of \$1,952. This is the remainder of their award.
