<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Sammy A. Jeromin	Fire	\$ 150	Mr. Jeromin is a Fire Engineer. He suggested that the department utilize rope bags to store and protect the lifeline. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Maria A. Cabrera Janice T. Love	Water Utilities	\$ 100	Ms. Cabrera and Ms. Love are Intermediate Typists in the Systems Division. They suggested that water locators' services be pre-scheduled by clerical staff. Although savings were difficult to calculate, this was considered to be a significant operational improvement.
Jack A. Mead	Park & Recreation	\$ 70	Mr. Mead is an Equipment Technician II in the Central Division. He suggested the design and use of a tool to simplify the removal of the end plate on the pool pumps. This is expected to save \$230 in the first year in labor and material costs.
Debra J. Wake	Police	\$ 65	Ms. Wake is an Intermediate Typist. One year ago she earned a partial award of \$140 for her suggestion to order name tags for civilian employees on an as-requested basis. One year's experience has shown a savings of \$675. This is the remainder of her award.
