

RESOLUTION NO. R-256885Adopted on JUL 27 1982

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Donna J. Evans	Police	\$ 55	Ms. Evans is a Field Representative. One year ago she earned a partial award of \$55 for her suggestion to forward non-evidentiary identification to NRC desks. One year's experience has shown a savings of \$1,121. This is the remainder of her award.
Janet V. Groves	Park & Recreation	\$ 50	Ms. Groves is a Recreation Specialist in the Central Division. She suggested that the parallel parking on Village Place in Balboa Park be changed to diagonal parking. Although savings were difficult to calculate, this was considered to be a significant public service improvement.
Geraldine J. Coley	Park & Recreation	\$ 35	Ms. Coley is an Intermediate Stenographer in the Coastal Division. She suggested that air deflectors be installed on floor registers in City buildings. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Eustis Nikas	General Services	\$ 25	Mr. Nikas is a Sanitation Supervisor in the Solid Waste Division. He suggested that a portable platform be attached to the dead animal collection truck. Such a platform was constructed and used by the Division, but it proved unworkable. The suggester's Division recommended that he be given an intangible award in recognition of his effort to increase safety and eliminate potential hazards.
