Joe E. Perry	General Services	\$ 20	Mr. Perry is a Sanitation Supervisor in the Solid Waste Division. He suggested that broken handles on wash brushes be replaced with metal handles to prolong the use of the brush. Metal handles were installed on two wash brushes at his work station. In the future, wooden handles with metal tips will be used at his work station. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Robert C. Nightingale	Planning	\$ 10	Mr. Nightingale is a Zoning Investigator in the Zoning Division. One year ago he earned a partial award of \$260 for his suggestion to eliminate the handling and filing of returned notices. One year's experience has shown a savings of \$904. This is the remainder of his award.
