WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the TIERRASANTA COMMUNITY PLAN, and that the portion of the 1971 ELLIOTT COMMUNITY PLAN within the Tierrasanta Community Plan be rescinded; and

WHEREAS, City Council Policy 600-7, requires that the public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the TIERRASANTA COMMUNITY PLAN and amendment of the GENERAL PLAN in order to retain consistency between said plans; and

WHEREAS, on December 10, 1981, the Planning Commission approved and recommended for adoption by the City Council an amended GENERAL PLAN; and

WHEREAS, California Government Code, Section 65869 provides that mandatory elements of the GENERAL PLAN may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to consider amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semi-annual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the TIERRASANTA COMMUNITY PLAN; and the recision of the portion of the 1971 ELLIOTT COMMUNITY PLAN within the Tierrasanta Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That this Council hereby approves that plan entitled TIERRASANTA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR-256890, with the provision that if the escrow does not close and the owner has to seek another buyer the matter, as it relates to Mr. Krutszch's piece of property, will automatically come back to the Council.
- 2. That the portion of the 1971 ELLIOTT COMMUNITY PLAN within the Tierrasanta Community Plan area be, and it is hereby rescinded.
- 3. That the TIERRASANTA COMMUNITY PLAN and the recision of the portion of the 1971 ELLIOTT COMMUNITY PLAN within the
