RESOLUTION NUMBER R- 256915

WHEREAS, THE GREAT-WEST LIFE ASSURANCE COMPANY, a Canadian corporation, and TITLE INSURANCE AND TRUST COMPANY, a California corporation as Trustee under Trust No. IR-2843-001-1, have requested an exchange of sewer easements; and

WHEREAS, the sewer facilities, in lot 2 of Resubdivision of Centerside, Map No. 10023, have been redesigned, which requires the quitclaiming of the existing sewer easement; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of THE GREAT-WEST LIFE ASSURANCE COMPANY and TITLE INSURANCE AND TRUST COMPANY, executed in favor of The City of San Diego, bearing date of June 15, 1982, conveying to said City a sewer easement in lot 2 of Resubdivision of Centerside, Map No. 10023, as more particularly described in said deed, is hereby approved. *RR-256915 - 1*

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on

file in the office of the City Clerk as Document No. RR- 256915-2  
quitclaiming to THE GREAT-WEST LIFE ASSURANCE COMPANY, a Canadian  
corporation, and TITLE INSURANCE AND TRUST COMPANY, a California  
corporation, all of the City's right, title and interest in a  
sewer easement in lot 2 of Resubdivision of Centerside, Map No.  
10023, as more particularly described in said deed.

3. That the City Clerk of said City is hereby authorized  
and directed to deliver said deeds, and a certified copy of this  
resolution, attested by him under seal, to be recorded in the  
office of the County Recorder.
