BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$121,167.00 by T.G.S. ELECTRIC, INC. dba ARROW ELECTRIC, a corporation, for the MODIFICATION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT VARIOUS LOCATIONS CITY WIDE 1982, Schedule Nos. 1, 2, 3, and 4 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 118126.
2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$24,000.00 from Capital Outlay Fund 30245, CIP No.62-213, FAIRMOUNT AVENUE AND MISSION GORGE ROAD to CIP No. 62-002, MINOR SIGNAL IMPROVEMENTS to supplement funds previously authorized by Resolution No. 256501, adopted on June 1, 1982.
3. That the City Auditor and Comptroller is hereby authorized to pay the San Diego Gas & Electric Co. the amount of \$243.00 from CIP No. 62-002, MINOR SIGNAL IMPROVEMENTS for work done in connection with the MODIFICATION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT VARIOUS LOCATIONS CITY WIDE 1982.




