APPROVING MAP OF ASHBY GLEN

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by DONALD R. ROGERS, a Licensed Land Surveyor, entitled "ASHBY GLEN Being a subdivision of Lot 4, Seedorf Heights, Map No. 2912, filed October 3, 1952, Lot 9, Alice Glen, Map No. 5440, filed August 7, 1964, Lot 1, Block 2, El Cerrito Heights, Map No. 1940, filed September 8, 1926, Lot 45, Piedmont Estates, Map No. 2897, filed August 8, 1952, all in the City of San Diego, County of San Diego, State of California, together with Adams Avenue and Ashby Street vacated to public use, and Ashby Street as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that
