WHEREAS, the Mission Beach Peninsula is an area of chronic traffic congestion aggravated by widespread parking in existing red curb, "No Parking" areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That all parking prohibited zones designated by red curbs or red markings on the pavement on the Mission Beach Peninsula south of Santa Rita Place be, and are hereby established as Tow Away Zones. The Mission Beach Peninsula is that portion of the City of San Diego bounded by the Pacific Ocean on the west, the Mission Bay Channel on the south, Mission Bay on the east and Santa Rita Place on the north, as shown on Exhibit A attached. The removal of any vehicles parked in such designated zones is hereby authorized pursuant to Section 81.09 of the San Diego Municipal Code.

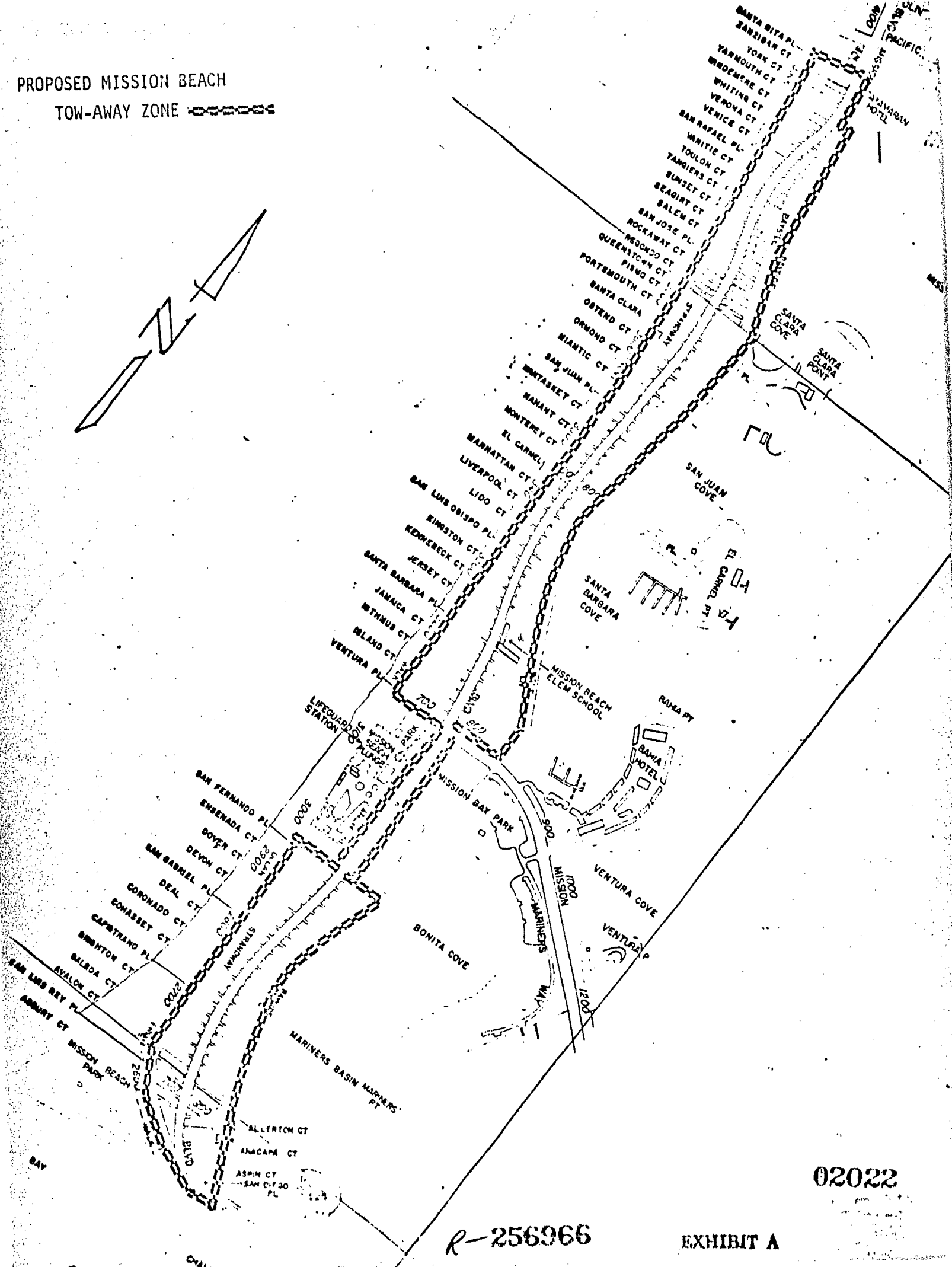
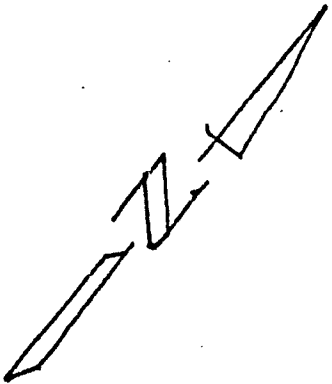
