RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ADOPTING PLANS AND PROFILE SHOWING CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. R-256096 ADOPTED MARCH 29, 1982 FOR THE IMPROVEMENT OF THE ALLEY IN BLOCK 33, LEXINGTON PARK; AND AMENDING SAID RESOLUTION OF INTENTION.

WHEREAS, this City Council did on March 29, 1982, adopt the Resolution of Intention No. 256096 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done in the said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the plans, drawings, typical cross-sections, profiles and specifications for the construction of various improvements in the ALLEY IN BLOCK 33, LEXINGTON PARK, heretofore filed in the office of the City Clerk as Document No. D-2195-2, be and the same are amended to conform with City of San Diego Engineering Department drawings, filed in the office

of the City Clerk as Document No. D-2195-2, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvements; the principal change being the deletion of the construction of the northwest portion of the Alley in Block 33, Lexington Park.

BE IT FURTHER RESOLVED, that Resolution No. R-256096 adopted March 29, 1982, be and it is hereby amended.
