That the acceptance by the City Manager of those easement deeds of COWLES MOUNTAIN ASSOCIATES, a general partnership, executed in favor of The City of San Diego, bearing dates of February 19, 1982, and July 16, 1982, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256984 -/ and No. RR- 256984-2, granting to said City easements for public street, slope and sewer purposes in a portion of Lot 70, Rancho Mission of San Diego, S.C.C. 15191, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named LAKE MURRAY BOULEVARD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
