
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 2, subsection IV.1 of the Annual Appropriation Ordinance, the Capital Improvements Program as contained in Document No. 00-15780-1, as amended, be and the same is hereby further amended by adding Project No. 29-446, entitled "Los Penasquitos Canyon Preserve - Improvements," to the fiscal year 1983 CIP Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer within Environmental Growth Fund 10505 the sum of \$15,000 from CIP No. 29-428, Los Penasquitos Canyon Preserve to CIP No. 29-446, Los Penasquitos Canyon Preserve - Improvements Project.
