audit services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Proposal to Perform an Independent Audit for The City of San Diego submitted by Peat, Marwick, Mitchell and Company, pursuant to the terms and conditions of the Proposal on file in the office of the City Clerk as Document No.

RR 25771 be and the same is hereby accepted and approved.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute, for and on behalf of said City, an agreement with Peat, Marwick, Mitchell and Company for a five-year period beginning July 1, 1982, pursuant to the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR 257912, at a cost not to exceed \$60,000.00 for Fiscal Year 1983.
