

RESOLUTION NUMBER R- 257023

Adopted on AUG 17 1982

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to execute an Amendment to Agreement between the City and the Housing Authority of The City of San Diego, pursuant to which Amendment three City-owned houses located at 7023 Fay Avenue, 6204 Beaumont Avenue, and 7127 Fay Avenue, respectively, shall be added to the 20 City-owned housing units presently being managed by the Housing Authority, a copy of which Amendment is on file in the office of the City Clerk as Document No.

RR- 257023 .

BE IT FURTHER RESOLVED, that City Council Resolution No. 216088 which designated said three housing units for administration by SOFA is hereby rescinded.

BE IT FURTHER RESOLVED, that revenues produced from the rental and management of said three houses, is hereby authorized and directed to be deposited into the General Fund.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to require the return to the City management and administration by the Housing Commission of all City-owned houses in the Fay Avenue Extension area as and when the individual houses are vacated by their present occupants and that all said houses be subsequently leased at their full fair market value.
