BE IT RESOLVED, by the Council of The City of San Diego as follows:



BIGGS, a Registered Civil Engineer, entitled "WINONA TOWERS Being a subdivision of Lots 15, 16, 17, 18, 19, 20, and 21 of Block 'G' of Montecello, in the City of San Diego, County of San Diego, State of California, according to Map No. 1154, filed in the office of the County Recorder of said County, December 12, 1908, (excepting therefrom said Lot 21 the southerly 12 1/2 feet thereof).", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, L & T CORPORATION, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the Office of the City Clerk, and in reliance on said assurance does hereby accept the final map of WINONA TOWERS.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
