BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 2:00 p.m., Sundays and certain holidays excepted be and the same is hereby established on the following streets in said City:

The north side of Kellogg Street between San Elijo and San Fernando Streets; the north side of Lawrence Street between Rosecrans and San Elijo Streets; the west side of Rosecrans Street between Lawrence and Nichols Street; the east side of Rosecrans Street between McCall and Nichols Streets; the west side of San Elijo Street between Jenkins and Kellogg Streets; the west side of San Elijo Street between Lawrence and McCall Streets; the west side of Rosecrans Street between Navy Gate and Kellogg Street.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
