James E. Bates	General Services	\$1,080	Mr. Bates is a Building Supervisor in the Buildings Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to amend the lease agreement with the State of California to allow for partial reimbursement for utility costs. One year's experience has shown an increase in revenue of \$3,600. This is the remainder of his award.
Lee R. Noorda	Manager	\$ 500	Mr. Noorda is an Electrician at the San Diego Stadium. He suggested that central controls be installed for the Stadium press level heaters. This is expected to save \$6,809 in the first year in energy costs. This is a partial award pending a final 12 month review.
