WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

Dennis L. Marnell	General Services	\$ 375	Mr. Marnell is an Equipment Mechanic in the Equipment Division. One year ago he earned a partial award of \$605 for his suggestion to replace the bolts attaching transmissions to refuse trucks with larger bolts. One year's experience has shown a savings of \$3,274 in repair costs. This is the remainder of his award.
Margaret D. Hoerger	Park & Recreation	\$ 355	Ms. Hoerger is an Intermediate Typist in the Central Division. She suggested that the Disabled Services calendar be revised. This is expected to save \$2,358 in the first year in labor, equipment and postage costs. This is a partial award pending a final 12 month review.
Lucille S. Alexopoulos	Risk Management	\$ 250	Ms. Alexopoulos was a Claims Representative I at the time of her suggestion. She suggested the development of a method to pursue Recovery actions arising from hit-and-run accidents. Although savings were difficult to identify, this was considered to be a significant operational improvement.
