

RESOLUTION NO. R-257056Adopted on AUG 24 1982

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Daniel Karsh	Police	\$ 150	Mr. Karsh is a Police Sergeant. He suggested that the Risk Management Department be designated as the hearing officer for post storage hearings for impounded vehicles. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Walter A. Gray	Engineering & Development	\$ 115	Mr. Gray is a Senior Engineering Aide. One year ago he earned a partial award of \$270 for his suggestion to revise the procedure for numbering and processing Encroachment Permits. One year's experience has shown a savings of \$1,287. This is the remainder of his award.
Carol L. Backus	Building Inspection	\$ 100	Ms. Backus was a Programmed Typewriter Operator at the time she submitted her suggestion. She suggested that lights and handrails be installed on the steps in the Community Concourse. Although savings were difficult to calculate, this was considered to be a significant safety improvement.
Robert L. Spangler, Jr.	Fire	\$ 100	Mr. Spangler is a Fire Engineer. He suggested that ropes used as lifeline be labeled. Although savings were difficult to estimate, this should result in improved accountability, record keeping and safety conditions.
