William F. Buck, Jr.	Fire	\$ 100	Mr. Buck is a Fire Engineer. He suggested the use of Tactical Work Boards at multi-alarm fires. Although savings were difficult to identify, this was considered to be a significant operational improvement.
John R. Crowell	Police	\$ 100	Mr. Crowell is an Evidence Technician. He suggested and developed a tool to simplify Crime Laboratory operations. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Jacqueline S. Clayton	General Services	\$ 65	Ms. Clayton is an Auto Messenger in the Buildings Division. She suggested that a color code system be used to simplify mail dispatching. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Pamela S. Allegra	Personnel	\$ 60	Ms. Allegra is an Intermediate Clerk. She suggested that the printing of scratch paper for Civil Service Examinations be discontinued. This is expected to save \$208 in the first year in labor and equipment costs.
