William J. Punch June V. Sandford	Property	\$ 50	Mr. Punch is a Property Agent and Ms. Sandford is an Intermediate Typist. They suggested that the insurance form letter be revised to inform lessees of the availability of insurance coverage which is continuous until cancelled. Although savings were difficult to indentify, this was considered to be a significant operational improvement.
Frank W. Weatherford	General Services	\$ 50	Mr. Weatherford is a Building Supervisor in the Buildings Division. He suggested that traffic warning signs be installed at the intersection of 19th and B Streets. Additional work has been included to be completed in Fiscal 1983.
Joanne S. Anderson	Library	\$ 25	Ms. Anderson is a Librarian II. She suggested that a form be developed to simplify library reserach. Although savings were difficult to identify, this was considered to be a significant operational improvement.
James H. Kline	Fire	\$ 25	Mr. Kline is a Fire Captain. He suggested that a mirror be installed in the alley behind Station #21. Although savings were difficult to calculate, this was considered to be a significant safety improvement.
